**Madison Consolidated High School**

The primary mission of the Community Foundation of Madison and Jefferson County, Inc. is to assist donors to build an enduring source of charitable assets to benefit the Jefferson County community. Many donors have sought to achieve this goal by endowing gifts for scholarships for higher education so that people like you will have a greater likelihood of reaching their potential.

Attached please find a list of scholarships currently available in the Community Foundation that Madison Consolidated High School seniors are eligible for.

- Unless otherwise noted, the scholarship application deadline is noon March 7, 2011.
- These awards are generally for tuition only. Therefore, students already receiving a full-tuition award from a college or another source are not eligible for Community Foundation scholarships.
- These scholarships are not renewable unless otherwise noted.
- Employees and board members of the Community Foundation, as well as family members of the aforementioned individuals, are ineligible for competitive Community Foundation scholarships. This includes spouses, lineal descendants and their spouses, and brothers and sisters and their spouses. The period of ineligibility extends through the calendar year following the year in which the volunteer position or employment ends.
- Family members of selection advisory committees are ineligible for Community Foundation scholarships. This includes spouses, lineal descendants and their spouses, and brothers and sisters and their spouses.

Jefferson County 4-H Scholarship

*Eligible Applicants:* Graduating seniors or recent graduates from any Jefferson County high school who have completed four years of regular 4-H. Intended to help students finance post high school educational programs at vocational schools, colleges, etc. Criteria evaluated: 4-H participation. Apply through the Jefferson County Extension Office.

Sharon Thom Alcorn Memorial Scholarship

*Eligible Applicants:* Graduating Madison Consolidated High School seniors majoring in education. Preference will be given to students who are interested in teaching English.

M.W. Anderson Scholarship

*Eligible Applicants:* Graduating Madison Consolidated High School seniors who attended M.W. Anderson/Michigan Road Elementary School for at least three years (six semesters). Criteria evaluated: scholarship/academic achievement, leadership, citizenship, extra-curricular activities, and financial need. For furtherance of education at a four-year college, two-year college, vocational or trade school.

Helyn Bishop Scholarship

*Eligible Applicants:* Graduating Madison Consolidated High School seniors who have attended Canaan Elementary School for at least three years sometime in their school career. Criteria evaluated: potential for success in a post high school educational setting and financial need. For furtherance of education at a four-year college, two-year college, vocational or trade school. Required: Two letters of recommendation from teachers and/or counselors of Madison Consolidated Schools.

#### Broadway School Alumni Scholarship

*Eligible Applicants:* Graduating Jefferson County high school seniors. Criteria evaluated: financial need, demonstrated academic ability, and demonstrated concern for school and community. Required: 200 word essay on the role the Broadway High School (that was located in the 600 block of Broadway, the first commissioned colored high school in the state of Indiana) played in the history of Madison.

#### Tiffany Lee Carter Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who will continue their education at a two- or four-year educational institution. Required: An essay of up to two pages about cystic fibrosis and/or the importance of organ donations.

#### Madison Chautauqua Scholarship For the Arts

*Eligible Applicants:* Jefferson County, Indiana high school juniors, seniors, and adult residents who wish to further their education in the visual or performing arts. May be used for tuition to attend a college, vocational school, IRS qualified summer study or short courses not leading to an academic degree. All art forms are eligible, including the visual and performing arts and photography. Required: Letter of recommendation from a person knowledgeable about your talent and accomplishments in your art form, along with a sample of your work in the form of slides, cassette, CD, or videotape, with a maximum of 3 slides and one 3-minute tape or CD. Note: This scholarship has its own application and may be picked up at your counselor's office.

#### The Chan Chilton Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who have participated in two or more men's varsity sports during their high school careers. For furtherance of post-high school education including, but not limited to, college, junior college, university or trade school. Qualified candidates shall have maintained a high school grade point average of 2.5 or better and demonstrated outstanding work ethic, sportsmanship, and citizenship.

#### Class of '84 Scholarship

*Eligible Applicants:* Graduating Madison Consolidated High School seniors with strong community service and leadership abilities. Academic performance is also taken into consideration. For furtherance of post-high school education at qualifying institutions including technical colleges, universities, trade schools, etc.

#### Joseph V. Cline Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who plan to pursue a college education. This scholarship is awarded to MCHS students who have contributed substantially to the student body and demonstrated a spirit of wholesome cooperation that has enriched the *esprit de corps* of the class and the school. One page essay and teacher recommendations required.

#### Thomas D. Craft Jr. Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who plan to pursue an education at a two or four year college or university. Criteria evaluated: Have demonstrated good citizenship, have performed community service, have a grade point average of at least 3.0 on a 4.0 scale.

#### Norma A. Cull Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who wish to pursue a career in journalism. Criteria evaluated: financial need, active participation in school publications and other media activities, shows interest in pursuing studies beyond journalism to include economics, government, history, or any other field which they might be required to report on during their career, demonstrates an interest in people by participating in community activities and organizations not related to their work or area of study.

#### Deputy Alumni Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who attended Deputy Elementary School for at least one year sometime in their school career and who are current residents of Graham Township. Criteria evaluated: potential for success in a post high school educational setting and financial need. For furtherance of post-high school education at qualifying institutions including technical colleges, universities, trade schools, etc. Required: Two letters of recommendation from teachers and/or counselors of Madison Consolidated Schools and proof of acceptance to a program for post high school education

#### Dupont Alumni Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who attended Dupont Elementary School for at least three years sometime in their school career and who are current residents of Lancaster Township. Criteria evaluated: potential for success in a post high school educational setting and financial need. For furtherance of education at a four-year college, two-year college, vocational or trade school. Required: Two letters of recommendation from teachers and/or counselors of Madison Consolidated Schools and proof of acceptance to a program for post high school education.

#### Mabel Green Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors in the upper 10% of their class. Criteria evaluated: financial need and interest in becoming a teacher or entering a profession.

#### Dennis Holt Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who played girls basketball for at least one year during their high school career. May be used for post-high school education, including but not limited to college, technical school, university, trade school, etc. Grade point average of 3.0 or above on a 4.0 scale is suggested.

#### Glenn G. & Dorothy Ebel Huntington Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who will pursue a four year degree in primary or secondary education. Special consideration given to applicants who exhibit a desire to become elementary school teachers. Required: One page essay describing why the applicant wishes to be a teacher.

#### Ralph & Robyn Jones Family Memorial Scholarship

*Eligible Applicants:* Jefferson County high school graduating seniors with a GPA of less than 3.7 and a family adjusted gross income of \$30,000 to \$50,000 per year. Those with higher incomes may be considered if extraordinary financial need can be demonstrated.

#### Charles H. & C. Chris Keller Scholarship

*Eligible Applicants:* Madison Consolidated High School or Shawe Memorial High School graduating seniors with a 2.0 or higher GPA who plan to attend an accredited technical or trades school or two-year college.

#### Dorothy B. Lotz Scholarship

*Eligible Applicants:* \$200 awards to Madison Consolidated High School graduates based on class ranking. No application required.

#### Lynn A. Maricle Musical Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who have demonstrated an interest and ability in music and/or the performing arts to further their education in these fields.

#### Terri Nighbert Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who intend to become nurses. Criteria evaluated: potential for success in pursuing a post high school education and financial need.

Brad O'Leary Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who have taken at least 3 years of Spanish and maintained a grade of "C" or better in Spanish classes. Criteria evaluated: demonstrated interest in continuing to use and improve Spanish speaking skills and financial need.

Troy Allen Pyles Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who have participated in Madison High School Band for at least four semesters during their high school careers. The award is intended for the average student who might not be eligible for other awards.

*Eligible Applicants:* Students enrolled at Franklin College. Applicants contact Franklin College's Financial Services Office for details. 1-800-852-0232 ext. 8075

Erin Turner Memorial Scholarship

*Eligible Applicants:* Madison Consolidated High School graduating seniors who plan on attending Ivy Tech State College, Madison campus. Intended for a good student who is eligible for few other awards.

Nathan Wilson Memorial Mathematics Scholarship

*Eligible Applicants:* Member of the graduating senior class of Madison Consolidated High School who has shown the greatest aptitude and achievement in mathematics. Financial need is also taken into consideration. No application required.

The Wood Memorial Scholarship

*Eligible Applicants:* Graduating high school seniors who live in the Ryker's Ridge community. Criteria evaluated: academic standing and financial need. For tuition at any accredited school, including colleges and universities, trade schools, etc.

Curtis Wright Memorial Scholarship

*Eligible Applicants:* Graduating seniors of Madison Consolidated High School who participated in cross country and/or swimming during their high school careers, and who intend to pursue a four-year college baccalaureate degree. The following will be evaluated: scholastic ability and participation in community activities. Required: A letter of recommendation from the Madison High School Athletic Department.
